Role Play Day 1

- There are 9 participating teams, with 2-3 members each.
- Teams will participate in pairs; there will be 5 pairs of teams. The pairings of teams will be the same throughout the day.
- Each pair will be in their designated breakout room (5 breakout rooms; Rooms 01 05). The pair will stay in the same designated breakout room throughout the day.
- There will be 2 volunteers in each breakout room; 1 Coordinator and 1 Timekeeper.
- Every pair will participate in 5 different scenarios throughout the day (Scenarios A –
 E).

- There will be 1-2 judges/actors for each scenario. The judges/actors will be assigned 1 specific scenario only. They will repeat their assigned scenario 5 times throughout the day in Rooms 01-05.
- Room 01 will start with Scenario A \rightarrow B \rightarrow C, and so on. Room 02 will start with Scenario B \rightarrow C \rightarrow D, and so on...

- There will be 2 volunteers in each breakout room (5 rooms total); 1 Coordinator and 1 Timekeeper.

Format of the oral rounds

- There are 9 participating teams, with 2-3 members each.
- Teams will compete in pairs during each oral round.
- Each pair will be in their designated courtroom for each round of the oral proceedings (5 breakout rooms; Rooms 01 05). The competing teams may not necessarily be in the same courtroom for each round of the oral proceedings.
- There will be 2 volunteers in each breakout room; 1 Bailiff and 1 Timekeeper.
- There are 3 rounds; General Rounds, Semi-finals, and Final Round.
- The General Rounds consist of 2 rounds of oral proceeding on the first day, one in the morning and one in the afternoon. All 10 teams will compete twice in 5 pairs, of which the pairings will be different between the first and second rounds.
- The Semi-finals consist of 1 round of oral proceeding in the morning of the second day. 4 teams will compete once in 2 pairs.
- The Final Round consists of 1 round of oral proceeding in the afternoon of the second day. 2 teams will compete once in 1 pair.
