The ICRC Regional Delegation in Bangkok seeks to fill the following position:

### **Supra Regional Movement Cooperation Coordinator, based in Kuala Lumpur**

**We are looking for a team player with a can-do attitude to join our team.**

The Supra Regional Movement Cooperation Coordinator acts as the ICRC's focal point and de -facto representative of the Regional Director of Operations for Asia and the Pacific for the cooperation and coordination with regional representatives of the International Federation of Red Cross and Red Crescent Societies in Asia Pacific Regional Office (IFRC APRO) and regional representatives of partnering National Societies based in Kuala Lumpur. S/he works within established policy and procedures, supporting the Regional Operations Director and Heads of Delegation in the region on matters related to IFRC APRO and the Regional PNSs. S/he maintains an overview of Movement partners dynamics and activities to be able to provide timely analysis and information to delegations and the Region. S/he contributes to build a fluid, timely and constructive interactions between the ICRC and the other Movement partners and facilitates joint Movement approaches on thematic areas in the Region. S/he is a member of the Regional Resource Network based in Bangkok, working closely with its members to ensure that cooperation and coordination issues within the realm of their files are considered in the planning and implementation. S/he provides advise to the Regional Resource Network members on matters pertaining to coordination and cooperation with Movement partners in the Region.

#### **ACCOUNTABILITIES AND RESPONSIBILITIES:**

##### Functional responsibilities

- Manages relationships and coordinates activities with other Movement components across the region. Support the Regional Director in positioning ICRC within the Movement in the Region in line with the priorities of ICRC institutional strategy 2024 – 2027.
- Facilitates dialogue and shared strategic orientations between the IFRC and the ICRC Regional Director of Operations, based on a coordinated approach and a roadmap on common areas of interest.
- Acts as the de-facto representative of ICRC Asia and the Pacific region on Movement affairs.
- Support the Regional Movement Cooperation Coordinator in Bangkok in strengthening and managing the relationship with Malaysian Red Crescent Society (MRCS) including overseeing the day-to-day cooperation engagement with MRCS.
- Steers ICRC initiatives to implement Seville 2.0 including the use and promotion of Strengthening Movement Coordination and Cooperation tools
- Follow up emergency appeals, disaster relief emergency funds (DREF) and IFRC Regional meetings and support Delegations in engaging with IFRC and the National Society in IFRC sub-regional leaders meeting.
- Facilitates joint Movement approaches to several thematic areas or common humanitarian issues and approaches on leadership trainings and meetings.
- Organizes and facilitates Movement leadership training and meetings in the region jointly with IFRC and the National Societies (e.g. Movement Induction Courses, etc.)
- Support and coordinate with the Regional Management Teams and Regional Resource Network colleagues on thematic areas with Movement Coordination/Cooperation dimension: e.g. Large-Scale Conflict Preparedness, Protection of family links, Safer Access, migration, climate change, resource mobilization, sexual violence, Mental Health And Psychosocial Support, engagement with ASEAN to ensure that our approach is aligned and consistent with the institutional positioning with the Movement and promote ICRC added value, complementarity and partnership with Movement partners.
- Works closely with the MOUV Division's Movement Operations and Thematic Coordinator to ensure alignment and consistent messaging on Movement issues and positioning of ICRC with Movement partners in the Region.

##### Scope and Impact

- Proactively contributes to APAC Movement affairs' strategies and is directly supporting and involved in their implementation vis-à-vis the IFRC and regional representative of the PNS.
- Directly contributes to implementing the Regional Movement cooperation and coordination priorities of OP\_ASIA
- Contributes to secure regional analysis of Movement dynamics and existing Movement capacities.
- Geographical remit: regional but provides input on global issues.

- Understands the roles of the components of the International Red Cross and Red Crescent Movement

### Professional Experience required

- At least one assignment as ICRC's Movement Cooperation Coordinator or equivalent experience is an asset.
- Strong strategic, analytical and programme management (planning, monitoring and evaluation) experience.
- Solid experience in National Society Development, Partnership Management and Operational Movement Coordination.
