5th South Asian Conference on IHL – Sexual Violence and Armed Conflict

The ICRC and the Government of Nepal have collaborated to organize the 5th South Asian Conference on IHL in Kathmandu from April 8-10, 2014. Senior government representatives from SAARC countries and Iran are attending this conference.

The prevalence of sexual violence in armed conflict and other situations of violence and the consequences for victims and their communities deserve recognition and a committed response from the international community, national authorities, and humanitarian stakeholders. In this regard, the conference has the following objectives:

- (1) Provide state officials of the South Asian region and Iran with a platform to discuss IHL and issues related thereto
- (2) Discuss developments in IHL and practice
- (3) Encourage states to become party to key IHL instruments and to take meaningful steps towards implementation of legislation, as appropriate
- (4) Facilitate dialogue between the ICRC, states and official government bodies, with a view to strengthening institutional dialogue and collaboration on IHL and related principles

Past South Asian IHL Conferences

International Humanitarian Law

International Humanitarian Law (IHL) is a set of rules which seek, for humanitarian reasons, to limit the effects of armed conflict. It protects persons who are not or are no longer participating in hostilities and restricts the means and methods of warfare. IHL is also known as the Law of War or the Law of Armed Conflict.

The development of IHL in modern treaty form started with the adoption of the First Geneva Convention of 1864, and expanded over time. The present body of IHL mainly contains two sets of rules: one set relates to persons (wounded, sick, prisoners of war, and civilians) affected by armed conflict, while the other regulates the methods and means (weapons) which may be used in armed conflict.

The four Geneva Conventions of 1949 represent the cornerstone of contemporary IHL, which are supplemented by three Additional Protocols: two adopted in 1977 and one in 2005. In addition, there are several other IHL treaties which regulate or prohibit certain categories of weapons, establish additional safeguards relating to children in armed conflict and establish protection of cultural property during armed conflict, to name a few – all of which encompass the expanding corpus of IHL.
