The Data & Analytics Officer supports the staff of the department/division with reporting, data and analytics to enable the evidencebased decisions and improvements in the performance of the department/division or in its area of expertise. Candidates should have an interest in fleet management, as this role requires a strong ability to analyze and optimize vehicle operations through data insights.
